About MOTIF-RACK XS Extension

“MOTIF-RACK XS Extension” is a set of program plug-ins and project templates developed by Yamaha to enhance the functions of Steinberg DAW software. Simply by installing MOTIF-RACK XS Extension and connecting the MOTIF-RACK XS to your computer, you can take advantage of various features which enable you to link Cubase (the Steinberg DAW) with the MOTIF-RACK XS.

This manual covers how to install MOTIF-RACK XS Extension.

NOTE

- MOTIF-RACK XS Extension is compatible with Cubase series (Cubase/ Cubase Studio/ Cubase Essential/Cubase AI) Version 4.5 or later.
- The system requirements of MOTIF-RACK XS Extension are the same as each DAW software.
- MOTIF-RACK XS Extension is a specific, dedicated program within the Extensions for Steinberg DAW which provides integrated features for the MOTIF-RACK XS.

In the following situations, it is necessary to replace Extension for Steinberg DAW with MOTIF-RACK XS Extension.

- Using Cubase series version 5 or later
- Using Yamaha Steinberg FW Driver
- Using Windows Vista (64-bit)

In other situations, you do not need to replace the Extensions for Steinberg DAW with MOTIF-RACK XS Extension.

For Windows Users

Preparing to install

Before installing, you will need to properly install the driver software to use MOTIF-RACK XS Extension. Make sure to install the USB-MIDI Driver software when connecting the MOTIF-RACK XS to your computer via a USB cable, or to install the Yamaha Steinberg FW Driver software when connecting the MOTIF-RACK XS to your computer via an IEEE1394 cable.

Installing the software

Follow the instructions below to install MOTIF-RACK XS Extension.

NOTE

- If the Extensions for Steinberg DAW is already installed on your computer, be sure to uninstall the Extensions for Steinberg DAW before installing the MOTIF-RACK XS Extension.
- Make sure to install this software under the “Administrator” account.

- 1 Double-click the “setup.exe” file extracted from the compressed file downloaded from the Yamaha web site.
- 2 Click [Next] on the “Welcome to the InstallShield Wizard for Yamaha MOTIF-RACK XS Extension” window called up in step 1.

NOTE

- “Welcome to the InstallShield Wizard for Yamaha MOTIF XS Extension 64bit” will call up in the 64bit version of MOTIF XS Extension.
- If a newer version of MOTIF-RACK XS Extension has already been installed in your computer, a dialog box appears indicating that the newer software has already been installed. In this case, you do not need to install the software. Click [OK] in the dialog box.
- If an older version of MOTIF-RACK XS Extension has been installed in your computer, the software should be updated. (The procedure is the same as that of installing it from scratch.)

- 3 Install the software by following the on-screen instructions.
- 4 Click [Finish] when “Completed” appears.

Uninstalling the software

Follow the instructions below to uninstall MOTIF-RACK XS Extension.

■ Windows XP

- 1 Select [Start] → ([Settings] →) [Control Panel] → [Add or Remove Programs] to call up the “Add or Remove Programs” window.
- 2 Click [Change or Remove Programs] located in the upper left of the window, then select “Yamaha MOTIF-RACK XS Extension” from the list in the right panel.
- 3 Click [Remove].
- 4 Follow the on-screen instructions to remove the software.

■ Windows Vista

- 1 Select [Start] → ([Settings] →) [Control Panel] → [Programs and Features] to call up the “Uninstall or change s program” window.
- 2 Select “Yamaha MOTIF-RACK XS Extension” from the list.
- 3 Click [Uninstall]/[Uninstall/Change].
If the “User Account Control” window appears, click [Continue].
- 4 Follow the on-screen instructions to remove the software.

NOTE

- You can uninstall the software by double-clicking the “setup.exe” file of “MOTIF-RACK XS Extension” (if it is the same version of that already installed to your computer), clicking [Remove], then clicking [Next] on the maintenance window.

For Macintosh Users

Installing the software

Follow the instructions below to install MOTIF-RACK XS Extension.

NOTE

- Before installing the Extensions for Steinberg DAW, make sure to start the computer and log on to the Administrator account.

- 1** Double-click the “Yamaha MOTIF-RACK XS Extension.pkg” file extracted from the compressed file downloaded from the Yamaha web site.
- 2** Click [Continue] on the “Welcome to the Yamaha MOTIF-RACK XS Extension Installer” window called up in step 1.

NOTE

- Click [Continue] if the message “This package contains a program that determines if the software can be installed. Are you sure you want to continue?” appears.

- 3** Install the software by following the on-screen instructions.
- 4** Click [Close] when a message indicating that installation has been completed appears.

Uninstalling the software

Follow the instructions below to uninstall MOTIF-RACK XS Extension.

- 1** Select [Library] → [Application Support] → [Steinberg] → [components], then delete the below files.
 - yamaha_motif-rack_xs.bundle
 - yamaha_motif-rack_xs_u.bundle
- 2** Select [Library] → [Application Support] → [Steinberg] → [Project Templates], then delete the file named “Yamaha_XXX.cpr” (“XXX “ indicates specific model name, etc.).

- **You may** use the SOFTWARE on a **single computer**.
